Introduction

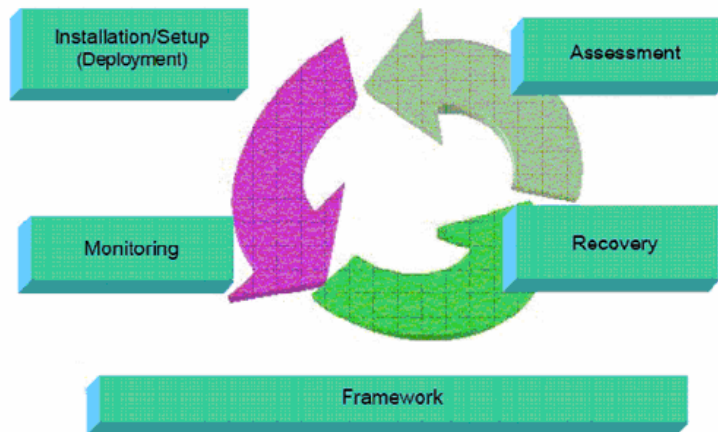
