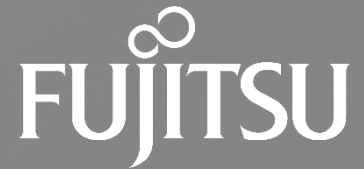

**1:** Keep at least one copy of the data offsite
