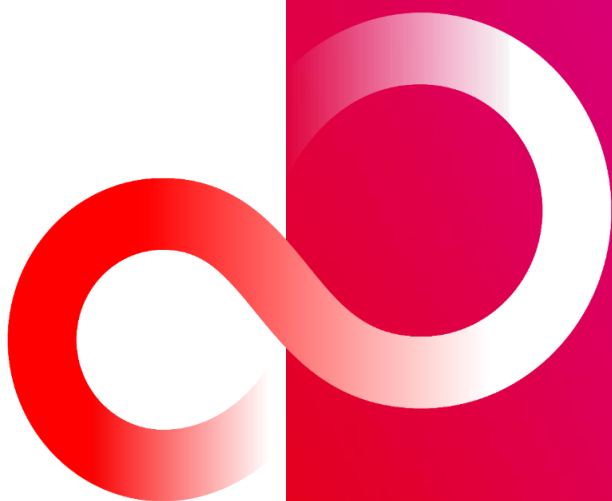




# Visa cashback reward



## PROMOTION TERMS and CONDITIONS

## Terms & Conditions :

1. Eligible Products means any of the following Fujitsu listed products :
  - Fujitsu LIFEBOOK 12<sup>th</sup> generation notebooks
    - U7312, U7412, U7512, U9312, U9312x
2. "Reseller" means a company that is responsible for the sale of an eligible product listed in the following terms and conditions and is a registered Fujitsu partner.
3. "Promoter" means Fujitsu Australia of 118 Talavera Road, Macquarie Park NSW 2113.
4. "Cashback Recipient" is a company or a person who will receive the cashback reward.
5. The promotional period commences October 19 – December 31, 2022. All claims must be submitted by January 13, 2023. Participants will forfeit claims made after this date.
6. The "Reward" means the cashback reward corresponding to the relevant Eligible Product listed above which will be delivered through a credit memo to the Distributor (not the cashback recipient directly).

4. Handwritten tax invoices and delivery docket will not be accepted as proof of purchase. Any claim form submitted without the required proof of purchase documentation will be rejected
5. The Promoter will accept no responsibility for late, lost or misdirected mail. Further, TO THE EXTENT PERMITTED BY LAWS of AUSTRALIA, the Promoter excludes liability for any problems or technical malfunction of any telephone network or lines, computer online systems, servers or providers, computer equipment, software, technical problems or traffic congestion on the Internet or any website, or any unauthorized intervention, or any combination thereof, including any non-delivery or corruption of entries to the Promoter, injury or damage to Participants' or any other person's computer related to or resulting from participation in or down-loading any materials in respect of this Promotion.
