# Notice of Change to Effective Date of Corporate Split

**Tokyo, July 30, 2009** – Fujitsu Limited ("Fujitsu") today announced that the effective date of the planned absorption-type separation to split off its hard disk drive (HDD) business and reorganize it into a wholly owned subsidiary, Toshiba Storage Device Corporation ("TSDC"), has been changed from August 1, 2009 to September 1, 2009.

# 1. Change to Effective Date of Corporate Split

### 2. Reason for Change

As previously announced on June 25, 2009, as of the effective date of the corporate split, Fujitsu plans to transfer 80.1% of the shares of TSDC to Toshiba Corporation ("Toshiba"). To prepare for the transfer, Fujitsu and Toshiba are taking necessary procedures in various countries in accordance with local competition laws. In a certain country, however, the governmental review process has not been completed, and therefore the companies have decided to extend the target transfer date to September 1, 2009. Accordingly, the effective date of the planned corporate split has also been changed.

# 3. Impact of Change on Financial Results

The above change is not expected to have a material impact on financial results for the current year.
