The G610 bill recycling unit sets a new standard when it comes to speed, capacity and reliability in a mid-level currency management system for the OEM sales channel.

The G610 has the capacities and flexibility that many smaller recyclers lack. The G610 can support up to 8,000 notes in full recycle mode (4 recycle cassettes) or up to 6,000 notes (3 recycle cassettes) for recycling and up to 2,300 notes in a secured depository. In addition, the G610 offers a very robust, lockable and removable 800 note reject cassette that can collect unfit, counterfeit or non-recycled currency.

With greater capacities and flexibility, the G610 may be the ideal OEM solution for teller assist, ATMs, bill payment or front or back-office cash management systems. In other words, the G610 is suitable for virtually any environment that handles larger sums of cash.

With Fujitsu's best-in-class bill validation, mixed new and used, paper or polymer notes are no problem. Up to 100 mixed, stacked notes can be placed in the acceptor module for deposit. Notes are then counted, validated (a complete image of the front and back of the media captured) sorted and stored; all in a matter of seconds.
